Spinal injuries are considered a [catastrophic injury](#) and can have devastating, long-term effects on your health and well-being. Each year, about 12,000 people are hurt and 450,000 are living with spinal cord injuries. Contrary to popular opinion, breaking one's back or neck does not immediately guarantee a spinal cord injury. There could simply be damage to the bone of the surrounding vertebrae, whereas a spinal cord injury would result in a loss of mobility or feeling. That's also what sets it apart from other injuries like ruptured disks, pinched nerves, or spinal stenosis.

Almost all causes of spinal injury stem from either trauma ([car accident](#), gunshot, a fall, etc) or disease (polio, spina bifida, etc) and don't even need to sever the spine; just damaging it is often enough to result in a loss of function. Recovering from such an injury is never easy—surgery, rehabilitation, ongoing medical care, and sophisticated medical devices may all be needed. Many people who sustain a spinal injury are burdened with costly medical bills, extensive rehabilitation, time out of work and dealing with insurance companies. And that means that even with medical insurance, very few people can afford complete treatment on their own. ## Reasons to File a Spinal Cord Lawsuit

Injury lawsuits are based on the fact that someone caused you a harm due to negligence. Basically, if it were not for their actions or poor inaction, you would not have suffered a loss. ***Car and motorcycle accidents are the cause of more than one-third of all spinal injuries in California. To be fairly compensated, you'll need to show that the other person was at fault.*** Maybe they were driving too fast or went through a stop sign. It may have just been inattention. Regardless of the reason, you'll have an opportunity to show their negligence and have a California court award you accordingly.

Seniors overwhelmingly suffer spinal [injuries because of unnecessary falls](#). All too often, home and business owners leave walkways cluttered, fail to install secure handrails or [don't clean up slippery materials](#). These are unfortunate things that result in dangerous falls. If something like this results in you being hurt, you may have a strong case for negligence.

It's not uncommon for manufacturers to recall defective products. We hear about [faulty brakes or airbags](#) frequently in the news. Products are required to pass government safety standards. When they don't and people are injured, these billion-dollar companies need to be held accountable. ## Statute of Limitations on Personal Injury Claims

Recovering from a spinal injury can be a lengthy process. Some people face a lifetime of problems from serious spinal cord injury accidents. It's important to understand that you don't have to wait until you've fully recovered or completed rehab to file a lawsuit.

***California statute of limitations allows injured parties up to two years to file a legal claim. The clock starts when the injury occurs and once the two years expires, you will lose your ability to start the compensation process.*** The exception to that rule applies if an injury wasn't immediately discovered. If an injury presents itself after the two-year period, you have one year to file from the date of discovery. Keep in mind that current and future medical treatment, as well as other costs, become part of the monetary resolution. By filing early, you secure the right to compensation later.

## Living with Paralysis as a Result of a Spinal Cord Injury

When someone suffers the traumatic effects of paralysis, the cost of medical care can exceed most people's means. During the first year, expenses can range from \$500,000 to more than \$750,000. Other motor function injury costs can exceed \$300,000. Ongoing costs can range from \$42,000 to nearly \$200,000 per year and the price of health care continue to increase.
