## Product Liability Law in California

The state treats a car door latch as a “product” for the purposes of evaluating responsibility for latch failure. Among the possible approaches in pursuing damages in faulty door latch situations is proving general **negligence**, or focusing on **strict product liability**. That’s why our team focuses so carefully on investigating the car door latch failure.

If you’re pursuing a strict [products liability](#) claim, you may need to show that the defect in the car door latch was the cause of the injury and that the defect existed before you bought the vehicle. Whether it’s a design flaw, mechanical or manufacturing error, or a failure to recall the vehicle when the flaw is known. Our legal team will work on your behalf to ensure your losses are recouped and in some cases, a jury may award punitive damages.

With a negligence claim, a strong case for recovered damages can be made if the auto dealer or the manufacturer is found to have been negligent in selling, making or designing the product — in this case, the door latch in the [car involved in the accident](#). When it’s obvious that the manufacturer or seller failed to warn you about the faulty car door latch, it’s advisable that you contact a lawyer to discuss a potential claim.
