In fact, ***a recent accident on the Timber Mountain Log ride at Knott's Berry Farm caused damage to a young boy's eye socket during a visit to the park.***

## California Amusement Park Injury and Laws

Amusement parks like Knott's Berry Farm are not regulated under state or federal laws, which allows them to continue to allow unsafe rides that may not even pass inspection requirements. These parks must be held accountable for personal injuries to guests due to the direct result of the malfunction of their rides, which can only be done if injured guests seek damages via a personal injury attorney in California.

The most common causes of amusement park rides are from mechanical failure, operator error, or guest behavior. ***In addition to guests being responsible for their own injury by failing to follow proper ride conduct, mechanical failure, such as malfunctioning safety equipment (lap bars and seat belts) can cause injury.*** Other injuries can be caused by the ride operator, who may not control the ride properly or lack experience or training for proper use. An investigation by our amusement park accident lawyer can ensure you are covered and taken care of.

## **Compensation for Amusement Park Injuries and Wrongful Death**

***California law allows compensation for victims of amusement park accidents that includes medical treatment, pain and suffering, lost wages, future earnings, and punitive damages*** to punish the amusement park for being negligent.
