


Resources for Sexual Assault and Abuse Victims in California

If you are a victim of sexual abuse these organizations could help;

California Coalition Against Sexual Assault (CALCASA): CALCASA, was founded in 1980 as an advocacy organization against sexual abuse. Within California, the organization advocates for prevention activities and offers technical assistance to prevention practitioners in building effective prevention measures. Rape Treatment Center: The center is based in Santa Monica and offers state of the art treatment for adult and child sexual assault victims. Other services include emergency medical care, crisis intervention, and therapy. The center also provides information about victim's rights. Visit RTC's website for more information.

Center Against Sexual Assault of Southwest Riverside County (CASA): The center is dedicated to promoting healthy, and safe relationships by empowering individuals affected by sexual abuse. East of Los Angeles Women Center: The center has trained and certified professionals who support victims in the following ways; counseling services, accompaniment services to local health centers, support services for family and friends of survivors. Their sexual assault hotline is 800.585.6231.

Women resource center (WRC): The Women's Resource Centre offers support to services, shelter, education, and counseling to sexual assault victims in San Diego County. The center is located at 1963 Apple St. Oceanside, CA 92054. Contact them at 760.757.3500 for emergency help services.

Riverside Area Rape Crisis Centre: Founded in 1973, the organization offers free of charge services to rape and sexual assault survivors. Shield Women's Self-Defense: SHIELD Women's defense system was founded in 2003; its founder was aggravated by a sexual assault incident on a friend before deciding to start the training program. The organization empowers women and girls by training them how to fight back during assault situations.
